Any recommendation made by a panel is subject to final approval by the affirmative action of a majority of the Board pursuant to NRS 213.133. Pursuant to NRS 233B.126, the Board is not required to accept public comment prior to the commencement or conclusion of a contested case or a quasi-judicial proceeding that may affect the due process right of an individual. No public comment will be accepted at this hearing.

The Panel reserves the right to take items in a different order to accomplish business in the most efficient manner. Agendas are subject to change and inmates may be removed from an agenda without notice.
