Any recommendation made by a Panel is subject to final approval by the affirmative action of a majority of the Board pursuant to NRS 213.133. Pursuant to NRS 233B.126, the Board is not required to accept public comment prior to the commencement or conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual. No public comment will be accepted at this hearing.

The Panel reserves the right to take items in a different order to accomplish business in the most efficient manner. Prisoners may be removed from this agenda for reasons including, but not limited to: a determination of ineligibility for parole; a prisoner not being available at the time of the hearing; the lack of available information to enable the Board to make an informed decision; a failure to properly notify a victim of his or her rights in accordance with NRS 213.131(4); or, a failure to properly notify a prisoner of his or her rights in accordance with NRS 213.131(9).
