The Board may close portions of hearings to accept confidential information as provided in NRS 213.131(8), -17-public comments from applicable victims during a public hearing pursuant to NRS 213.131(4). Any person wishing to provide written input on any of these cases may provide it, in writing, in advance of the hearing, or may present it in person at the start of the hearings at the parole board location where the hearings will be held. Any victim wishing to testify at a hearing may provide that input at the onset of the hearings. The Board will not entertain verbal input from any person other than the victim in this case. Agendas are subject to change and offenders may be removed from an agenda without notice. The Board reserves the right to take items in different orders to accomplish business in the most efficient manner.
