IV. For discussion only: Discussion on the application and impacts of Assembly Bill 267 (2015), which, in part, provides that a prisoner who was sentenced as an adult for certain offenses that were committed when he or she was less than 18 years of age is eligible for parole after the prisoner has served a certain number of years.

Attorney Kristina Wildeveld addressed the attendees via cell phone. She discussed her experiences working with and representing youthful offenders and the different obstacles they face when going from prison to parole and the effect of AB267.

Ms. Welborn from the ACLU addressed the attendees and discussed the handout "Parole Board Consideration for Individuals".

Chairman Bisbee commented on the handout and information shared by Ms. Welborn and introduced Mr. Taylor, a former inmate of the Nevada Department of Corrections who was incarcerated at the age of fifteen.

Chairman Bisbee had invited Mario Taylor to speak with the Board regarding his time incarcerated as a juvenile in an adult prison. Mr. Taylor spoke of his time in prison, difficulties he encountered, and the adjustments he had to make after he was granted parole.

Chairman Bisbee asked the attendees if they have any questions that they would like to present to the speakers.
