Reinstate with house arrest for up to 90 day TBA by P&P</p> <p>(for sex offenders consider moderate level response if moderate level violation provided sex offender assessment is low or moderate and case facts suggest a moderate level response is appropriate--they are administratively supervised at a high level/risk)</p>
